PRESIDENT'S REPORT

In summing up the year, the club's 52nd season has been incredibly successful, both on and off the field.

When the current committee first met in late 2014 we set about defining a set of clear objectives, and after 12 months of really hard work and perseverance we can safely say that almost all those objectives have been met, or well underway, except for the additional social facilities & facilities improvement plan which until about 2 months ago was going to plan.

The committee is made up of 14 parent volunteers, who have given up their time to meet each month to help steer to the club to one of its more successful seasons in recent times. I would like to thank each of the committee members who were gracious enough to donate their time, money and expertise to the club by volunteering on the 2015 committee. The club and all of its members ought to be very proud & thankful to this group of parents who worked incredibly hard throughout the year.

I am sure that the children of the committee will one day look back at their parents' involvement in the football club and thank them for their leadership, their willingness to donate their time without ever asking for anything in return, and for showing them the spirit of community.

My role as President was certainly made so much easier with the support of the committee, and the many volunteers that were so willing to assist where needed.

Social Events & Fundraising Efforts

The club operates as a ~~not for profit~~ entity+with the biggest expense for the year being the playing fees paid to the league (WRFL). The playing / registration fees collected fall a long way short of covering even just the WRFL costs let alone any other club expenses, therefore there is quite an effort required to generate the \$40,000 -\$50,000 needed to keep the club from running a deficit.

There were a number of strategies put in place to make up the shortfall, but the major fundraising strategy was through the 20 plus social events the club ran throughout the year. Dean Martin and his subcommittee / helpers did an amazing job this year again. The events were well run and strongly supported by the parents & families within the club. We must also acknowledge the local & wider Williamstown Business Community for their generous support / donations / sponsorship and attendance at our functions throughout the year.

WJFC – Community & Social Responsibility

The members, players, parents & spectators have represented the club proudly throughout the year showing wonderful sportsmanship to the opposition with our victories, and a great positive attitude and team spirit in games when the finals scores didn't go our way.

The club regularly shows why it is the club of choice within the Western Region, but a clear stand out effort was with the Pink Socks Fundraiser & Pink Jumper Raffle . 2 great initiatives created as a show of respect for one of its own members earlier this year in conjunction with Breast Care Network Australia (BCNA) . Special Mention to Darren & Alyson Ryan for their efforts. There are already plans in place for the 2016 season where the entire club will be involved.

The sight of between 100 - 150 kids & parents, dressed in Williamstown Juniors uniform walking down to the Williamstown Cenotaph to lay a wreath of support, and attend the ANZAC Day Dawn Service & Breakfast at the RSL indicated to the older Williamstown residents / Returned Servicemen & Women that their efforts and sacrifices aren't lost on our members and players alike. Great effort by everyone who attended the local Dawn Service.

Relationship with Williamstown Auskick

The Williamstown Auskick clinic operates out of Bayside on a Saturday morning and has enjoyed a good but distant relationship with WJFC, until the 2015 season where we invited Tyrone Lewis (Auskick Coordinator) to join our committee.

There is direct synergy between the 2 clubs with the majority of the new under 9s coming through from Auskick. Throughout the 2015 season we have worked on a number of cross promotion events, functions and of course the Grid Games played at the Williamstown VFL home games at Burbank Oval

Relationship with Williamstown CYMS

As a junior only club the alignment with Williamstown CYMS is important for the players looking to develop their football journey beyond the under 16 age group. The club is working really hard to ensure the smooth transition from junior football to senior football with CYMS is as easy as possible for the players.

Relationship with Williamstown Football Club

In addition to the financial sponsorship from Williamstown VFL this year, WJFC has been really pleased with the strong support from Jason Reddick (CEO), Craig Byron (Community & Player Welfare Manager), Andy Collins (Senior Coach) and all the support staff.

The support of our club was shown early on in the year when at the launch Andy Collins publicly addressed to our members how valuable it was to them to see lots of junior kids at their home game matches, whilst at the same time the senior players were running drills & handball comps with the kids.

In addition to seeking sponsorship from local businesses the club elected to become a Player Sponsor of Lachlan Hunter . Western Bulldogs . for season 2015. In return the Western Bulldogs donated a number of experiences to the club in which we were able to auction at our event. Lachlan played his junior football with Williamstown Juniors, and is one of 3 current AFL listed players, the others being Elliot Kavanagh (Essendon) & Trent McKenzie (Gold Coast Suns).

WJFC Apparel

A key objective for the committee was to create a strong **WJFC Brand** with the design, production and sale of an extended range of club apparel. For many years now the players have received an item of apparel included in their registration fees. Our players have a full off field uniform, which is regularly commented on and the envy of many of our opposition.

In 2015 we embarked on an ambitious program to create a clothing & apparel range for adults, siblings & supporters. Total apparel purchases were close to \$30,000 net (including the players item) whereas in previous years this figure has been significantly lower.

Throughout the year the committee regularly opened up a small apparel stall at training, game days and at functions. The profit margins on the apparel were very slight and although it generated a modest gain, the main aim was to have as many supporters, parents and siblings decked out in the WJFC gear as possible.

Joint Coaching Program between WJFC & Willy CYMS Amateurs

The previous committee endured many years of planning, meetings, discussion & debate as to how the 2 clubs could create a better pathway for the junior players to be ready for the transition to senior football within the amateur competition. Credit must be paid to the former committee for their forward thinking!!

The coaching pathways program concept was created by Matt Montebello . Senior Coach & Director of Coaching at Willy CY~~Y~~. The program was originally designed to assist the players & coaches of the under 14~~Y~~-16~~Y~~, but with the introduction of another key appointment . Ben Kelly as the Coaching Coordinator, the program quickly evolved and was made available to all 15 teams starting from the under 9~~Y~~ up.

I think the on-field results throughout the year, including the development of the players across all levels and the resources & knowledge provided to the coaches has shown that the program, albeit in its pilot year was a huge success. With a further 2 more years left on the pilot we look forward to the continued success.....

Matt & Ben~~Y~~ commitment to the program has been encouraging. A big thank you to the coaching squad, including the assistant coaches for embracing Matt & Ben~~Y~~ philosophies.

The elephant in the room.....Council – WRFL - Langshaws Oval.....

Throughout the year the committee had budgeted for, planned and established fundraising efforts to include the addition ground & social facilities at Langshaws Oval which the council had **Committed** to the club for the 2016 season.

There has been significant debate and some disquiet amongst members of the club during the year about the club accepting the offer of the addition ground / social facilities given their location in Altona North.

In late July, the WRFL requested a meeting with the Club to inform them that they would be supporting Newport Powers application to the council to be allocated Langshaws Oval in 2016, instead of WJFC.

Since July, the executive committee has been in deep discussion with council, the league and even the local Member of Parliament to seek a satisfactory outcome for the members of the club.

It is certainly a watch this space situation.....

WJFC is fast becoming the club of choice.....feedback from the Hobson's Bay Council Mayor!

Thanks again for the invitation to your Family Day & Season Launch and for certainly making me feel very welcome!

TREASURER'S REPORT



Williamstown Junior Football Club Inc.
Financial Report
For the 11 months ended

WJFC made a profit of \$21,526 for the financial year ended 31 August 2015, compared to \$14,143 in 2014. This comprised of:

- 1 An operating revenue net of SportingPulse Fees of \$51,279 (2014: \$56,669) from a total of 302 players (2014:347) which is an average of \$170 per player (2014: \$163).
- 2 Total Operating expenses totalled \$77,568 (2014: \$82,018)
- 3 The largest expense is the WRFL compulsory administration fee which was \$29,238 (2014: \$35,068).
- 3 This income and expense resulted in an Operating Loss of \$28,114 for 2015 (2014:\$25,349)
- 4 Net Non-Operating Profit was \$49,640 (2014: \$39,492). It is important to note that without significant fundraising activities involving significant time and effort from volunteers, the club would have ran at a significant loss.

Further detail of the income and costs are contained in the attached Profit and Loss and Detailed Finance Commentary.

Please note that the Financial Statements have been audited by Mr. Paul Sherman CA and his audit report is contained in this report.

WJFC maintains a healthy balance sheet with \$122,630 cash under Management (2014:\$99,948). This cash is maintained for future capital expenditure at the Bayview Site subject to additional Council funding and approval from both the Council and the school.

Apparel holding at the end of the Financial Year equals \$6,913 and is all saleable stock to be sold in the 2016 year.

The only liabilities for the club includes Accruals of \$3,000 which are invoices for the 2015 paid after 31 Aug 2015.

There is a provision of \$1,229 for new playing jumpers.

Our club paid for the two electricity invoices for the winter months, and high cost is due to the field lighting for training nights, although some cost is for the Canteen. There is not a significant increase in electricity from the prior year, rather it is due to that the final invoice from AGL was not accrued in 2014. This amount to \$1062 and was paid this financial year, and is included below is the category called "Net Prior Year Income Expenses not Accrued". \$1000 has been accrued for this year for the electricity invoice which is expected. Being 28% higher than the prior year, this year's cleaning cost includes an additional clean of the away rooms due to an unexpected U10 friendly game under the final clean. So two final away room cleans were conducted. This also includes the cost of cleaning at the Pearson for each of the functions held at the CY Clubrooms.

Insurance - Building and PI - 251 1,612

A review of the Committee determined that the Club was doubling up on this insurances having Building and Contents, and Public Liability both as separate policies and through the WRFL Administration fee. The duplicated separate policies were cancelled during the year, and the ongoing renewal not taken up. It was noted that the WRFL contents insurances were not sufficient and for a small additional premium to JTL through WRFL policy, the value has been increased. Contents (fire and perils) cover is \$50k (increased from \$15k) and Theft cover is 20k (increased from \$15k).

The Canteen Operations were affected this year by the scheduling of teams by the WRFL, the reduced number of teams, the lack of spectators at the final games of the day, allocated byes for teams, and increment weather on some Saturdays. Canteen revenue was down 15% on prior year and Coffee Income 19% down. Whilst expenses was 69% of income compared to 66% of income in 2014. This would be to do with CPI increases of supplies not sufficiently reflected in the selling price, and the lower volume of sales in some days resulting in some wastage of perishable foods.

Significant delays in the manufacture and shipping resulted in items not being available when promised. This was resulted in \$6.9k worth of stock at the end of this financial year. However, the Sponsors have committed for the 2016 season and therefore this stock will be able to be sold during the 2016 season. The ongoing Committee will need to factor in this level of stock held on the balance sheet before considering any major stock purchases for 2016.

It is important to note that without these activities both in the 2014 and 2015 the club would have run as a significant loss. The loss from Operational activities was \$22k in 2015 and \$25k in 2014. Leading to a pleasing \$21.5k profit for 2015 compared to 14k for 2014, an increase of 52%. However, it should be noted that this increase of \$7.3k over the profit year came from a significant increase in effort by the Committee in the following area:

1. Additional Social functions including the Season Opening Function, and increased Sunday Sips.
2. Increase in Apparel operations
3. Increase in Canteen lines
4. Increase in Sponsorship efforts

It is important that in the Committee's proposal for the increase in fees to the Members at the AGM the operational loss is considered as this level of operational loss is not viable.

Note 1. Significant accounting policies

The principle accounting policies adopted in the preparation of the financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

Basis of preparation

In the committee's opinion, the company is not a reporting entity because there are no users dependant on general purpose statements. These are special purpose financial statements. The committee has determined that the accounting policies adopted are appropriate to meet the needs of the members.

The financial statements have been prepared under the historical cost convention and do not take into account changing monetary values. The accrual and going concern basis have been adopted.

Revenue recognition

Sales revenue is recognised at the point of sale. Amounts disclosed as revenue are net of returns and discounts.

Other revenue is recognised when it is received or when the right to receive payment is established.

Trade receivables

All trade receivables are recognised at the amounts receivable as they are generally due for settlement within 30 days.

Inventories

Inventory is stated at the lower of cost and net realisable value. Cost comprises purchase and delivery costs, net of rebates and discounts received and receivable.

Depreciation of plant and equipment

Depreciation is calculated on a straight line and diminishing value basis to write off the net cost of each item of plant and equipment over its expected useful life. Estimates of remaining useful lives are made on a regular basis for all assets, with annual reassessments for major items.

Trade and other payables

These amounts represent liabilities for goods and services provided to the entity prior to the end of the financial year and which are unpaid. The amounts are unsecured and are usually paid within 30 days of recognition.

Provisions

Provisions are recognised when the entity has a present (legal or constructive) obligation as a result of a past event, it is probable the entity will be required to settle the obligation, and a reliable estimate can be made of the amount of the obligation. The amount recognised as a provision is the best estimate of the consideration required to settle the present obligation at the reporting date, taking into account the risks and uncertainties surrounding the obligation.

Goods and Services Tax (GST)

The Incorporation is not currently registered for GST.

Well done to Dean and his team.

JOINT COACHING PROGRAM REPORT



2015 Football Williamstown Coaching Pathway Report



The Clubs

2015 has been a big year for both Williamstown Juniors and Williamstown CYMS football clubs. Williamstown Juniors fielded multiple sides in each age group. Only the U14s age group had only one side fielded. The ability to field a large number of teams are due to the strong community links the club has. This starts with Auskick. Williamstown Juniors were successful in many of its age groups in particular winning the 12As, 13As, and 14Cs grand finals.

Williamstown CYMS had a first with promotion to Premier C for the first time in club history. The club fielded 5 teams. Three open age teams seniors, reserves and thirds with 2 underage teams U19s Section 3 and Colts (2nd tier U19s). The seniors consolidated their first year in Premier C finishing 7th while the reserves and thirds just missed finals. The U19s played off in the preliminary final.

At the end of the 2014 season the Football Williamstown coaching pathway was established. The aim of the program was to provide coaches of the U14s and 16s more hands on support through expertise coaching instruction and resources. (This was the model was currently in place at Williamstown CYMS with my Director of Coaching Coach overseeing all 5 CYMS teams.) A coaching selection panel was established of Martin Bokma (Football Operations), Ben Kelly (Williamstown Juniors Development Coach) and myself (Director of Coaching) to select the U14s and 16s coaches.

After the selection of these coaches it was identified that the coaches of age groups 9s-13s would also be keen to be involved in the program. This was taken on with enthusiasm, as it would allow a more consistent approach across not only the two clubs but across all of Williamstown Juniors.

The Program

At the heart of the program is the Football Williamstown Football Curriculum. The curriculum has been designed to provide coaches with a framework to guide coaches in what they need to teach their players. The curriculum is broken into age specific skills and is progressive. The curriculum was presented to the coaches in the second workshop.

The program would see Ben be the man on the ground with the U14s-16s while I would oversee the U9s-13s. Although this was the desired structure at times we would cross over to keep variety for the coaches. Throughout the program 6 workshops were run. These workshops were as follows

Supporting the workshops was training support roster. The roster would see Ben rotate each week from the 14s to 16s, while I would work my way through 9s-13s. The roster allowed me to observe, assist and run sessions for each age group at least twice throughout the year with the U12s, 14s and 16s having sessions at the Fearon supported by senior CYMS players.

Every coach was provided with training and game day resources throughout the program and any specific needs were catered for via 1on1 meetings where resources were created for the teams and coaches specific needs. Ben and I made ourselves accessible at anytime for the coaches, assisting them either in person, on the phone or via email in matters ranging from game tactics to training methods.

In reviewing the program a SWOT analysis was undertaken by Ben and myself. This analysis is listed below.

Program Review

From the start of the program the support from the team coaches was fantastic. Throughout the year attendance at the workshops were high and ongoing feedback was positive. Starting a program like this for the first time was always going to have some growing pains as we searched to find the balance of what coaches needed, wanted and required.

The attached SWOT analysis and coach survey feedback gives us a strong framework to work with in 2016. In looking ahead we feel there are essential items that need to be altered.

Adjustments

Workshops

An adjustment to the workshop structure we feel is essential. The large variations in age groups create a variety of different needs. We would be looking at holding only 2 workshops with all coaches while the other 4 will be split amongst the following age groups.

- Group 1 U9s & 10s
- Group 2 11s-13s
- Group 3 14s & 15s
- Group 4 17s & 19s

This new structure will allow for a greater focus on the age levels of the football curriculum. It will also mean that we can ensure assistant coaches are also involved in these workshops.

Resources

Although resources were emailed out consistently they were either accidentally deleted or lost. Through either a club drop box account or iTunesU course club officials and coaches would have ongoing access to the resources that are required.

Training Support

A training support roster will be posted in 2x 10-week blocks. This will allow for more efficient planning.

All coaches will undertake 1on1 meetings to assist in with personalization. This time will be devoted to planning training specifically for the age groups needs. Each coach should have 2 1on1 throughout the season as a minimum with the second 1on1 used as a mid season reflection opportunity.

Player Development

To support the teaching of the Football Williamstown Essential Curriculum the establishment of a Football Williamstown Academy would occur. This academy would be for players in the age bracket of U13s-15s. The program would take place 4 weeks prior to Christmas one 75min session per week, while recommencing in mid January to March. The academies objective is to provide specialized skill based football coaching to Williamstown Junior players over the course of the summer. Myself and Ben as part of the coaching program would run this program.
